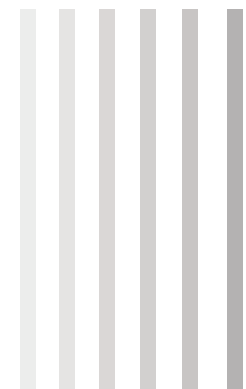

उपलब्ध सुविधा, पायाभूत सुविधा, तसेच कुशल मनुष्यबळ या निकषांवर सविस्तर तपासणी करण्यात आली.
