J.B.Chemicals announces completion of its transaction of Sale of Russia-CIS OTC Business to Cilag GmbH International

J.B. Chemicals announces the successful completion of its transaction of sale of Russia-CIS OTC Business to Cilag GmbH International ("Cilag"), Switzerland, a wholly owned subsidiary of Johnson & Johnson, along with transfer of worldwide rights and registrations of three OTC brands namely Doktor MOM, Rinza and Fitovit. On May 23, 2011, the board of directors had approved the sale of this business and OTC brands to Cilag.

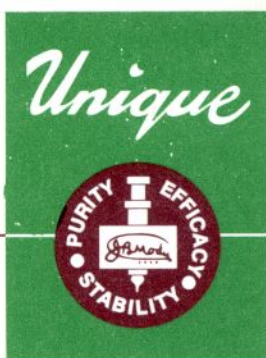
The company's Russian subsidiary has also achieved successful completion of its transaction of sale of OTC inventory and receivables to Johnson & Johnson LLC, a Cilag's affiliate.

Following successful completion of customary conditions, the company has received, in terms of various transaction documents, a consideration of approx. Rs. 738 crores, and an agreed portion of the consideration in escrow account. Likewise, the company's Russian subsidiary has received consideration of approx. \$ 35 million.

Effective today, the Russia-CIS OTC Business along with OTC brands now vests in Cilag. The Company would now supply the acquired products to Cilag for these markets.

"This is a milestone event and a result of stakeholders' faith in the company. We look forward to strengthening and growing our relationship with Johnson & Johnson" said Mr. J.B. Mody, Chairman & Managing Director, commenting upon the closure.
