Sub: Outcome of Circular Resolution passed by the Nomination, Remuneration and Compensation Committee

Dear Sir/Madam,

This is to inform you that the Nomination, Remuneration and Compensation (NRC) Committee of the Board by way of passing a Circular Resolution on 10th April, 2026 have inter alia transacted the following business:

1. Approved the allotment of 35,250 Equity shares of Rs.10 each under Employees Stock Option Plan 2007 (ESOP-2007) scheme to the eligible employee of the foreign subsidiary Company on exercise of stock options vested in him.
2. Approved the allotment of 1,12,418 Equity shares of Rs.10 each under Employees Stock Option Plan 2018 (ESOP-2018) scheme to the eligible employees of the Company on exercise of stock options vested in them.
