The Company has received an order dated March 30, 2026 ("Order") from the Assistant Commissioner of State Tax, Junagadh, levying on the Company a penalty of Rs. 15,38,402 under Section 74 of the Gujarat Goods and Services Tax, 2017, the Central Goods and Services Tax Act, 2017, read with applicable provisions of the Integrated Goods and Services Act, 2017.

The Order has been passed alleging incorrect avilment of input tax credit by the Company. The Company intends to file an appeal against the Order.

The financial impact of the Order is to the extent of the penalty levied. There is no impact on operations or other activities of the Company due to the Order.
