Sub: Intimation regarding divestment by a wholly owned subsidiary of the Company.

With reference to the captioned subject, we would like to inform you that the Company has received an intimation (on November 10, 2025 at 3:46 P.M) from Adani Airport Holdings Limited, ("**AAHL**"), a wholly owned subsidiary of the Company, that AAHL has executed a Share Purchase Agreement ("**SPA**") and Joint Venture Agreement ("**JVA**") on November 10, 2025 with World Plate Collective Cuisines Limited ("**WPCCL**"), a wholly owned subsidiary of AAHL and AJ Holding Limited ("**AJ Holding**") in relation to disinvestment of AAHL's 25% stake in WPCCL. Upon completion of contemplated transaction, AAHL and AJ Holding shall hold equity shares of WPCCL in the ratio of 75:25.
