Opinion

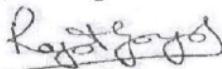
We also performed procedures in accordance with the circular issued by the SEBI under Regulation 33(8) of the Listing Regulations, as amended, to the extent applicable.

- (b) The consolidated annual financial results include the audited financial results/financial information of five subsidiaries, whose financial results/financial information reflects total assets of Rs. 4718.10 Lacs as at March 31, 2024, total revenue of Rs. 6172.06 Lacs, total net profit after tax of Rs. 277.36 Lacs, total comprehensive income of Rs. 297.90 Lacs and net cash outflow of Rs. 12.56 Lacs for the period ended on that date, as considered in the consolidated annual financial results. These financial statements has been audited by the other auditors whose reports have been furnished to us by the management and our opinion on the Statement, in so far as it relates to the amounts and disclosure included in respect of these subsidiaries is based solely on the reports of the other auditor.
