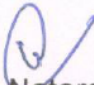

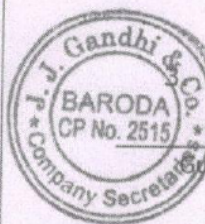

- A. 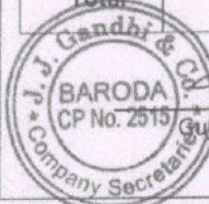

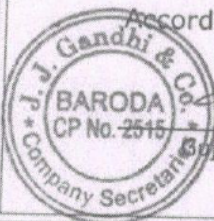
