Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”), we would like to inform you that, Adani Logistics Limited (“ALL”), a material subsidiary of the Company has entered into Joint Venture Termination Agreement on June 20, 2025 with Riddhi Infocom Solutions LLP (“Riddhi”) for divestment of 49% stake in Veracity, a joint venture between ALL and Riddhi. ALL will continue to hold 1% stake in Veracity.
