With reference to the captioned subject, we would like to inform that Astro Middle East Ship Management DMCC, step down subsidiary of Sunrise Worldwide Enterprise Limited in which The Adani Harbour International FZCO (step down subsidiary of the Company) holds 80% stake, has incorporated a Wholly Owned Subsidiary ("WOS"), namely, Astro Ship Management Angola (SU) LDA on May 18, 2026 (certificate received on May 20, 2026).

The proposed entity has been established to conduct its offshore operations locally in line with the Company's marine strategy to diversify its fleet globally. This development further reinforces APSEZ's strategy to build one of the world's largest integrated marine platforms, while expanding the geographic reach of its marine business.
