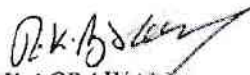

The matter placed before the Board and the reason for the delay in financial results. Non-submission of Audited Consolidated Financial Results for the quarter and year ended March 31, 2025;	Due to non-receipt of the Audited Financial Results of some of the subsidiaries of the Company, the Company was not able to file the Audited Consolidated Financial Statements with the exchanges within the due time.
