



The Notice had also been placed on website of the Company at www.sylvanply.com and e-voting website at www.ivote.bigshareonline.com and was also available on the website of stock exchange at www.nseindia.com.
- 3. We submit our report as under:
  - i. The Notice of Postal Ballot dated June 23, 2025 along with the statement under Section 102 of the Companies Act, 2013 setting out all material facts in respect of the resolutions mentioned therein was sent electronically by email to the members whose names appear in the register of members/ list of beneficial owners as provided by Depositories as on 27th June, 2025, Friday ("Cut-off date").

- ii. The Company has completed the dispatch of Postal Ballot Notice by email on June 30, 2025. In accordance with the MCA Circulars, no physical ballot notice was dispatched to the Members. The Company has also published Newspaper Advertisement in Business Standard (English) and Aajkal (Bengali) respectively, regarding dispatch of Notice of Postal Ballot alongwith Remote E-voting Information and containing all the matters required under Companies Act, 2013 and relevant rules on, July 01, 2025.
- 4. Postal Ballot has been conducted in compliance with the provisions of the Companies Act, 2013 and SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015.
- 5. Company has offered E-voting through **Bigshare Services Pvt Ltd** and the report contains the details of remote e-voting only.
- 6. The facility of remote e-voting remained open 9.00 a.m. (IST) on Wednesday, 2nd July, 2025 and ends at 5.00 p.m. (IST) on Thursday, 31st July, 2025.
- 7. After closure of remote e-voting, we have unblocked the votes cast through remote E-voting in the presence of Mr. Aditya Kumar and Ms. Khushboo Kumari who are not in the employment of the Company.
