2. The Resolutions were transacted through the process of remote e-voting only. For the purpose of remote e-voting, the Company had engaged the services of Bigshare Services Private Limited.
3. The Members of the Company holding shares as on the "cut-off" date i.e. Monday, December 01, 2025 were entitled to vote on the resolutions stated in the Notice of the Postal Ballot.

5. The hard copies of the Notice along with Postal Ballot forms and pre-paid business envelope were not sent to the Members for the Postal Ballot in accordance with the requirements specified under the MCA Circular. Accordingly, the communication of the assent or dissent of the Members took place through the remote e-voting system only.
6. The facility for e-voting was made available for the Members whose email addresses were registered with the Company/ Depository Participants ('DPs').
7. The register, in accordance with Rule 20(4)(xiv) and Rule 22(10) of the Companies (Management & Administration) Rules, 2014, has been maintained electronically to record the assent or dissent received, mentioning the particulars of name, address, folio number or client ID of the members, number of shares held by them. There were no shares with differential voting rights in the Company, hence there is no requirement of maintaining the list of shares with differential voting rights.
8. The related papers with respect to Postal Ballot will be handed over to the Company for safe custody of the same after the Chairman or any person authorized by him, signs the minutes/report of Postal Ballot process.
9. After the closure of e-voting, the report generated from Bigshare Services Private Limited e-voting website [ivote.bigshareonline.com](http://ivote.bigshareonline.com) on the voting done through Postal Ballot were unblocked, in the presence of two witnesses Ms. Anjali Singh and Ms. Palak Karwa neither of whom are in the employment of the Company.
10. The Management of the Company is responsible to ensure compliance with the requirements of the Act and rules thereunder, MCA Circulars and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to remote e-voting on the resolutions contained in the notice of the Postal Ballot.
11.
