### Additional Note:

You are requested to please note that the Company has allotted the equity shares as per the sanctioned scheme of Arrangement as approved by the Hon'ble NCLT vide its order dated 30th August, 2024 to be read with Corrigendum order dated 11th September, 2024.

However since the shareholders of Transferor Company 2 (Savla Oil and Gas Private Limited) were holding their respective holding in physical form, therefore as per the applicable rules and regulations, the shares were allotted in the dematerialized form and have been credited in the escrow account maintained in the name the Company on behalf of the entitled shareholders of Transferor Company 1 & Transferor Company 2.

While all other equity shares held by the promoters and promoter group have been credited in their respective demat accounts, but as on the date of filing of this intimation and as on March 31, 2025, 97,21,036 equity shares held in the name of Rupesh Savla Family Trust forming part of the promoter group are still lying in escrow account due to procedural requirements.

Hence, to give the true and correct view of promoter shareholding, We have considered them as they were allotted in their respective accounts, making the total shareholding of promoter & promoter group to be 10,98,37,209 (80.23%)
