Pursuant to the provisions of Regulation 31(4) of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, I Saket Agrawal, promoter of MSP Steel & Power Limited, holding 2,04,000 (0.04%) equity shares in the Company do hereby declare on behalf of all the promoters and promoter group/ persons acting in concert (PAC) that as on March 31, 2025, that 16,24,60,359 (28.66%) nos. of equity shares belonging to the promoter and promoter group is encumbered/pledged. I also hereby confirm that during the financial year 2024-25, the Company has not made any encumbrance, directly or indirectly, other than those disclosed below.

Additionally, I wish to inform you that pledge was created by the Promoter and promoter group (Pledgors) on 16,24,60,359 (28.66%) nos. of equity shares of the Target Company i.e., MSP Steel & Power Limited ("MSPL") in favour of SBICAP Trustee Company Limited ("STCL"). STCL is acting as the Security Trustee against the restructuring package of the credit facilities provided by the consortium of Lenders wherein State Bank of India is the Lead Bank. The shares of the Target Company are pledged in favour of STCL by the Pledgors as security for securing the repayment of the said loans. Since the pledge was created through depository system, hence, separate disclosure under Regulation 31(2) of Takeover Regulations was not made pursuant to proviso of Regulation 31(2).
