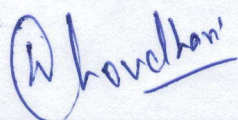

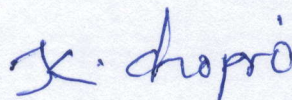

The approved Resolution Plan envisaged various corporate actions, including the extinguishment of the shareholding of the erstwhile promoters and the allotment of shares to the new promoters.

The Company has duly filed the necessary forms with the Registrar of Companies, Pune. However, the corresponding compliances and corporate actions with CDSL, NSDL, and the Stock Exchanges are currently in process due to certain procedural issues at the respective authorities.

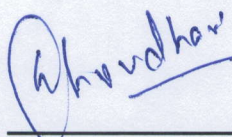

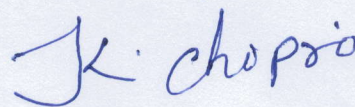
