# The Company is under liquidation; therefore, the consequences of Regulation 34 of Delisting Regulation will not apply to this Company

The consequences of compulsory delisting include the following:-

- The above companies will be ceased to be listed on the Stock Exchange. These companies will be moved to the dissemination board of the Stock Exchange (except Companies under Liquidation).
- In terms of Regulation 34 of Delisting Regulations, the delisted company, its whole-time directors, person(s) responsible for ensuring compliance with the securities laws, its promoters and the companies which are promoted by any of them shall not directly or indirectly access the securities market or seek listing of any equity shares or act as an intermediary in the securities market for a period of ten years from the date of such delisting.
- In terms of Regulation 33 of Delisting Regulations, the onus of giving exit to the public shareholders is on the promoters of the company. In case exit is not provided by the promoters, appropriate action would be taken against them.

Any person who may be aggrieved by the proposed delisting may make representation, if any, to Delisting Committee of the Exchange in writing on or before September 09, 2021.
