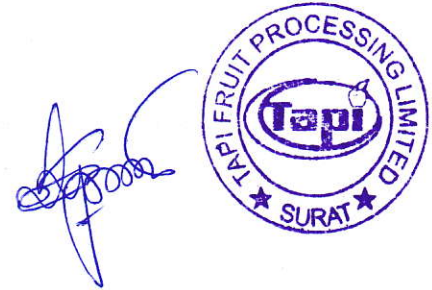

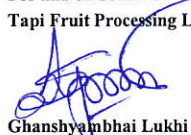

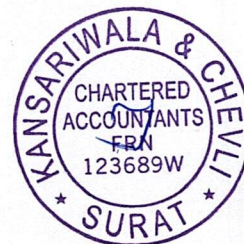
**Report on the audit of the Standalone Financial Results**

**Opinion**

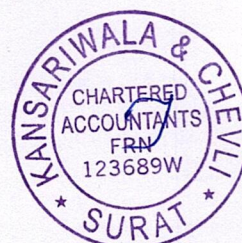
## **Management's Responsibilities for the Standalone Financial Results**

The Board of Directors are also responsible for overseeing the Company's financial reporting process.

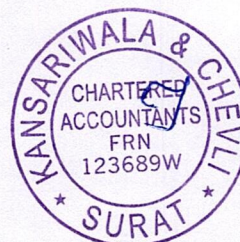


## **Auditor's Responsibilities for the Audit of the Standalone Financial Results**
