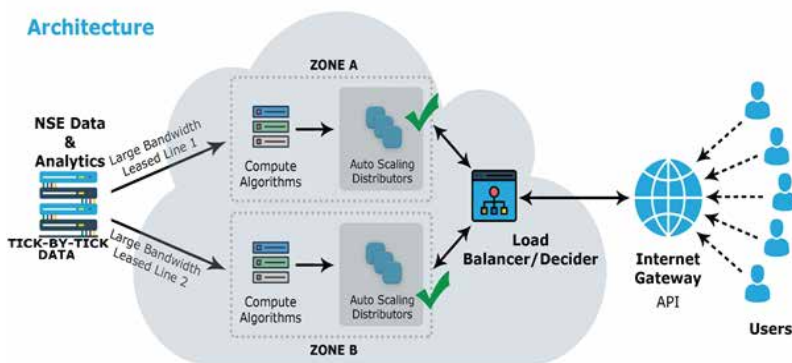
The Analytics will be available for the following segments:

- 1) Cash Market (CM)
- 2) Equity Derivatives (FAO)

### Key Features

- The calculations are done on the order and trade data visible in the order book for each instrument
- The Analytics are updated at different time interval (per second and per 60 seconds)
- The information is derived from real time tick by tick data
- These analytics will be available only during trading hours
- Order and trade information is anonymized

Clients will be able to avail the data via web application on per second/ 60 seconds frequency. The analytics output data will be available via API.

## Analytics

In this product, overall 46 Analytics will be available and the calculation will be on a scrip/ contract level and as per the frequency (per second/ 60 seconds).

Few examples of Analytics are given below:

- Number of arrived buy/ sell orders
- Quantity of arrived buy/ sell orders
- VWAP of buyer-initiated trades
- The ratio of the number of buyer-initiated trades to the number of seller-initiated trade
- VWAP of new orders/ all Trades
