Corporate Action Adjustment for ITC Ltd. in Nifty indices

NSE vide its circular NSE/CMTR/65845 dated December 27, 2024 has announced special pre-open session to be conducted for ITC Ltd. (ITC) in Capital Market segment on January 06, 2025 on account of demerger of company's Hotel business into the ITC Hotels Ltd.

In accordance with the index methodology, demerged entity ITC Hotels Ltd. (with a dummy Symbol "DUMMYITC") shall be included at zero price without divisor adjustment in following indices effective from January 06, 2025 (close of January 03, 2025).
