

NSE Quiz – Series 5 – Test Your Knowledge on Capital Markets

TERMS & CONDITIONS

1. Indian citizen aged between 18+ years can participate.

2. Quiz Registration starts from 17th October 2024.

3. Quiz starts from 21st October to 29th October 2024

4. Time: 9 AM to 9 PM

5. Each player to get 20 questions for 10 minutes (30 seconds/question).

6. Each player to get only one attempt during the entire duration of the quiz. Both email Id and mobile number entered during registration should be unique. Same email id or mobile number will lead to disqualification.

7. A live picture will be clicked every 2 minutes during the quiz. During the winner declaration if there is a mismatch between the registration and live pictures, the participant will be disqualified to become a winner. If there is a mismatch between the registration and live picture of the referred user, the set referrals will not be counted.

8. A maximum of top 30% of the total participants (subject to 130 participants) per day will be declared as the winners

9. Out of that 30% of the total winners each day, 10% of the top winners will receive ₹ 1000 ONDC voucher and remaining 90% will receive ₹ 500 ONDC voucher subject to maximum 130 winners/day.

11. Participants who participated in Quiz Series 4 can participate in the Quiz Series 5 but will not be declared as a winner or win prize. They will get participation certificate and earn through referrals.

12. Participants who refer new users with their referral code will receive ₹ 25 for each referred user.

13. A participant can provide maximum 10 referrals. Maximum amount earned - $\stackrel{>}{=}$ 250 will be transferred to their digital wallet.

14. Only those referred users will be counted as a referral who register and participate in the quiz.

14. The organizer's decision on the Quiz competition shall be final and binding.15. You will be required to provide your name, email address, mobile number, city. By submitting your contact details, you will give consent to these details being used for the purpose of the Quiz.

16. Once the mobile number and email address is entered, it cannot be updated later. Be careful while entering the details as it will be required for claiming the prize.
