SECTION IV – INTRODUCTION

OBJECT OF THE ISSUE

The sub-section titled “*DETAILS OF THE PROJECT*” on page 30 of the Draft Fund Raising Document shall be replaced as follows:

DETAILS OF THE PROJECT – “VIVEKA TRIBAL CENTER FOR LEARNING”

This project aims at to provide Education to the underprivileged children with a special focus on the girl child under the institution named Viveka Tribal Center for Learning based on the recommendations of the National Education Policy 2020.

Education of the underprivileged with a special focus on the girl child

Viveka Tribal Center for Learning caters to tribal children residing in and around Mysuru District in Southern Karnataka. The school is located in Heggadadevanna Kote (H D Kote) taluk has a population of over 2.6 lakhs with 90.2% people living in the rural areas and only 9.8% living in urban areas.

Reason for being underprivileged population

The taluk is one of the most backward taluks of the state of Karnataka and continues to perform poorly as per the Human Development Index (HDI) and other development indicators.

The taluk also has a sizeable population (est. 18,000) of the forest-based tribal groups namely Jenu Kuruba, Kadu Kuruba, Yarava, Soliga and Paniya. The tribal settlements are called haadis and the 127 haadis of the taluk are sparsely located along the fringes of the Bandipur and Nagarhole National Parks.

The Jenu Kuruba community forms the majority of the indigenous tribal groups in the taluk and are among the most primitive tribal groups in the country. Most of them are employed as agricultural labour and migrate during the harvest seasons to the neighbouring districts. Much of this community continues to live in poor socio-economic conditions.

These tribal community who are originally forest dwellers were thrown out of forest due to two major development projects of Government- 1. Regulation of the forest Act and declaration of Tiger Reservoir along the Bandipur & Nagarhole National parks. 2. Construction of the Kabini Dam along the same area.

There was no structured rehabilitation & resettlement done for these tribal communities which is one of the main reasons for the Poor socio economic conditions. These communities, originally dwelling in the forest, were relocated to 127 haadis along the remote fringes of the forest.

These difficult conditions has resulted in the limited access to primary health, elementary education and other facilities.

KEY APPROACHES

Following are the approaches which will be implemented by the Society to meet the ultimate object of the issue-

Focus on the girl Children

The school has given importance to education of the girl child as the tribal girl children are married off as soon as they reach their adolescence.

Tribal children and women are Anaemic by nature which could be due to lack of access to required nutrition needed for their growth and development. This has remained as a unaddressed challenge because of the economic challenge and their migration to different places in search of livelihood.

This poor health condition has also resulted in High Risk Pregnancies among most of the Tribal Women.

Lack of awareness among the tribal parents on the adverse consequences of early marriages, are also one of the main reasons.

All such health and social challenges are either limiting access to basic education for the girl children or they are dropping out of school at an early age.

These multiple issues can be addressed through the holistic education approach of VTCL focusing on Girl children.

This situation is slowly changing which is indicative by the number of admissions increasing from 12 (27%) to 218 (51%) over the last 30 years.

The school collaborated actively with the other departments of the organization and the Government to ensure that every girl child is admitted to school along with ensuring completion of education and appropriate nutritional supplementation.

Adoption of technology to promote learning & access to education with focus on Sports & Arts Integration of vocational education & enabling children to make informed career choices

Educating tribal children needs a different approach which should carefully focus on sensible aspects that has emerged as socio economic challenge inhibiting the tribal development. The education methodology is designed by analyzing the approaches which are contextually relevant & culturally appropriate making it acceptable by the tribal community.

Academics (including co-scholastic areas) & Learning Outcomes – To promote flexibility along with achieving the desired learning outcomes, the school shall design engaging content for children in their curriculum. This is done with Technology Enabled education – with audio visual curriculum designed to make the concepts more clear for students and also provide hands on experience for better understanding.

Technology usage in VTCL

VTCL students from class 8 to 10 are exposed to technology enabled solutions to access rich multimedia digital content of the state board curriculum which primarily address on improving the conceptual understanding among the students and improve result. School also has smart boards installed in classroom for the audio-visual curriculum. The audio-visual learning materials encourage self-paced peer-to-peer learning among the High School students. In addition to technology enabled solution STEM offers hands-on exposure to students to enhance their skills and improve the knowledge on science concepts by doing experiments under the guidance of our teachers. Also, VTCL has a computer lab which can be used by up to 20 students at a time. Students also are trained with Do-it-yourself kits of science and math concepts. Primary children are provided numeracy kit and other board games to encourage them to learn math with simple approach

Integration of Arts, Sports & Skills and Setting Benchmarks – Promoting talented students from among the tribal communities by integrating arts, sports and skills into the regular curriculum. Natural talents in sports & performing arts are identified among children and they are further coached to excel in the specific talent. They are also provided exposure to certain platforms to showcase their talent and encourage them to take it up as a career.








Vocational Education - Students are also Introduced to Basic Technology from class 6th to 10th. Here the basics of Mechanics, Plumbing, Electronics and agriculture and other skills for livelihood are provided for children. These children during their 10th class are also assigned to take up community projects to implement these skills practically. So that they identify their strengths and plan their career ahead enabling them to make informed career choices.


